## Financial Aid Department Visits Area Schools

The Financial Aid Department of Black River Technical College has been busy making visits to area high schools to discuss financial aid options available to students preparing to continue their education at the college level. "We go over the FAFSA (Free Application for Federal Student Aid) and explain the methodology behind it – what everything means," said Brandi Chester, Financial Aid Officer. "The FAFSA determines eligibility for all types of federal aid including the Pell grant, Stafford Loans, and work-study."

Requirements for the Arkansas Academic Challenge Scholarship are also discussed during the meetings as

well as BRTC scholarships that are available. "I encourage the students to do lots of scholarship searching on the internet," Chester added. "I emphasize to them how important it is to apply for any and every scholarship they can get their hands on. We give handouts listing a lot of useful websites for scholarships and other financial aid information."

Since November, department representatives have visited Pocahontas, Hoxie, Walnut Ridge, Black Rock, and Delaplaine schools. Employees representing BRTC at the financial aid meetings include Chester, Mary Anderson, and Carolyn Collins of the Financial Aid Depart-

Discussion and readings at the January Serendipity meeting centered on the theme, "Families in Collision" and featured a Hemingway short story and an excerpt from the best selling novel set in Afghanistan, *The Kite Runner*. The meeting included a growing number of Serendipity members who attend monthly luncheon meetings and discussions.

The organization is sponsored by the BRTC Department of Continuing Education and Business Outreach and the BRTC Foundation. It is designed to bring together community members for thought-

provoking discussions and fun at monthly meetings, with this year's theme of "Themes in Dreams: Stories from a Small World."

Serendipity Coordinator Dr. Jan Ziegler, Vice President for Development, said the readings are clustered around different topics each month, and feature short readings. The organization is an outreach project of the BRTC Development Office and serves as a way to connect the community to the college. "This activity directly supports the mission of the college to provide lifelong learning," she said. "It is designed especially for those who are retired or nearing retirement, or even those who wish they were," she added. "We know that keeping our minds active and stimulated leads to healthier lives, and Serendipity is one way we can do that."

Verna Smith and Ramonda Housh, nursing instructors at BRTC, attended a SimMan mannequin training in Gatesville, Texas this past month. “We went to a two-day intensive workshop to learn how to install, put to-

gether and run the SimMan mannequin recently purchased for the nursing department,” said Housh.

SimMan, produced by the Laerdal Medical Company, is an interactive patient simulator used for healthcare training. The realistic, anatomically accurate mannequin is programmed to speak and communicate specific health problems and simulate realistic vital signs to allow for a variety of realistic patient care scenarios. “We will be setting him (SimMan) up and training the other instructors in the coming weeks,” noted Housh. “We have ordered additional equipment and supplies needed to run the mannequin and have rearranged the lab into modules to simulate various hospital situations.”

Once operational, the virtual mannequin will be utilized by the departments of Nursing, Respiratory Care, Phlebotomy, and EMT/Paramedics.

BRTC students to complete their degrees. A second new car will be presented to an eligible student at the May graduation.

# Single Parent Scholarships Impact Growing Numbers

Since its inception in 1992, the Mary Sallee Single Parent Scholarship program has provided scholarship assistance totaling over \$57,000, representing more than 140 awards to single parent residents of Randolph County.

According to records compiled by Vickie French, Administrative Assistant to the President at BRTC, the scholarships have been awarded to 71 different individuals pursuing degrees in higher education. The

scholarships amounts have grown to the current award level of \$500 for full-time students for the fall or spring semester, and \$250 for part-time students or for summer enrollment.

MSSPS Chair Janna Guthrey expressed her appreciation to the contributions of the BRTC faculty, staff, Board members and other guests during the college’s annual fundraising event, a silent auction at the Christmas potluck. A certain

amount of funds raised locally are matched up to 150 percent by the statewide Single Parent Scholarship Fund. The BRTC Foundation also provides a funding stream for the program.

“This program makes a huge difference in the lives of single moms and dads who want to build a better life for themselves and for their children. I am very pleased with the support the employees and the Foundation are giving this pro-

gram,” Guthrey said.

# Charlotte Power, Others Honor MLK

Among the guest speakers and presenters at the January 16 Eddie Mae Herron Center celebration of Martin Luther King Day was Dr. Charlotte Power of BRTC. She joined a full house of guests and other presenters, including State Representative David Cook, Harmon Seawel, WBC choral students and students at Alma Spikes Elementary School and Pocahontas Middle School.

Dr. Power reminded the audience that Dr. King’s dream was in some respects still not realized. He advocated, she pointed out, that all people earn a living wage, something that is not universally the case in America today.

Power acknowledged the importance of efforts of the local community in preserving the Eddie

Mae Herron Center, formerly the AME church and a one-room segregated school for the African American students until the Civil Rights movement. She concluded by saying that all should work together to eliminate prejudice and injustice based on ethnicity, class and other characteristics.

Pat Johnson, Eddie Mae Herron Center Board President, coordinated and facilitated the event, which began with a march to the center. A large number of students participated through song, readings, and display and discussion of their art work commemorating the life of the slain civil rights leader. WBC students performed spiritual selections.
